BASIC DESCRIPTION OF ITEM¹: This resolution approves the Purchase and Sale Agreement for unoccupied excess properties on the west side of Wolf Road owned by the Airport. The purchaser is Sterling Pursuit, LLC and Chicago Executive Airport is the seller. We have vetted this piece of property through both CMT on Master Plan implications and our corporation counsel. They and airport staff agree that there would be no adverse effect to selling the property. These properties were released from the Airport Layout Plan by the FAA in 2012. The sale price is \$350,000. The earnest money is \$10,000. The Notice to Proceed date is September 29, 2023.
